**A. The following information is being provided as additional information to be added to the Request for Proposals (RFP):**

**1. Under Section B. Submittal Requirements , Submittal, Proposals,** the statement that reads as follows: "Proposals should be limited to a total of 10 pages in no smaller than 12 point font on 8 ½ " by 11" sheets," is hereby amended to read as follows:

**"Proposals should be limited to a total of 10 pages single-sided or 5 pages double-sided in no smaller than 12 point font on 8½" by 11" sheets."**

**B. The following information is being provided as confirmation of what is stated in the RFP:**

**1. Section C. Scope of Work, item 3) a) 10. states the following:**

"The coin-operated machine vend prices for all locations listed on Attachment 1 [of the Request for Proposals] shall be \$1.00 per wash and \$1.00 per dry (45 minutes for gas and 60 minutes for electric, with incremental additional time charged at \$.25 for 15 minutes)."

**This statement remains unchanged.**

**C. The following response is provided in answer to questions asked by the deadline for questions of 12:00 Noon on Monday, July 12, 2010:**

**Question No. 1:** Can you provide monthly gross income figures for the past 24 months? Please indicate any changes to the machine vend price and their timing, along with any additions or reductions of the properties serviced.
