Question 1. We are interested in coming to the site meeting on Friday March, 14th 2025. Is it mandatory to come to the 3/21/25 site visit too?

<u>Response:</u> Site meetings are not mandatory unless specifically stated as such. Two site visits are scheduled to provide flexibility, allowing bidders to attend either one based on their availability.

Site visits are offered to give prospective bidders the opportunity to assess the project for themselves and determine if further questions might need to be answered prior to submitting a successful bid.

All prospective bidders are strongly encouraged to attend a site visit. Non-attendance on the part of the Bidder shall not relieve the bidder of any responsibility for adherence to any of the provisions of the bid documents or any Addenda.

Question 2. Is the Pre-bid meeting mandatory?

Response: See answer to Question 1.

Question 3. If the street needed to be closed and who is responsible for permits?

<u>Response:</u> SHA has initiated a street tree removal permit but has not completed this until we have a contractor selected. SHA expects contractor to complete and submit a street use permit, which includes a traffic control plan, to complement the street tree removal permit that SHA has initiated. The street use permit will need to address street and sidewalk closure needs.
