The Seattle Housing Authority (SHA) for itself or as an agent for another SHA related entity (hereinafter "SHA"), is soliciting Submittals/Proposals from qualified individuals and businesses interested in performing the following:

**Project Description:**

The Seattle Housing Authority (SHA) is seeking a qualified artist to participate in the One Year Artist Residency Program associated with the redevelopment of Yesler Terrace.

In August of 2015, the Seattle Housing Authority initiated a multi-year art plan, funded by the Kresge Foundation, to bring the arts and artists to the Yesler community. SHA is currently in the process of a complete redevelopment of the Yesler Terrace site, which SHA initially developed in the early 1940's as the city's first publicly subsidized housing. The overall transformation of Yesler has consistently been guided by core values of social equity, economic opportunity, environmental sustainability and stewardship as well as ensuring the continued availability of low income housing. The low-rise, wood frame buildings that served low income households for seventy years are being replaced with mixed-income, mixed-use buildings that will range from low- to high-rise. The population of Yesler will increase from the roughly 1,200 people in the past to 12,000 people in the next decade or so. There will also be several thousand workers within several high-rise office buildings. New streets are being built, along with several new parks, public spaces, and pedestrian walkways. The community will be well-served by transit, including a new streetcar connecting Yesler to other nearby neighborhoods.

Artists are defined as dynamic thinkers interested in engaging with the world through creative forms. Artists working in all disciplines (including but not limited to visual arts, social practice, digital media, performance, dance, and literary arts) are encouraged to apply. The selected Artist in Residence will focus on creating experiences, enabling collaboration, and building relationships through direct involvement with Yesler residents. Artists are also strongly encouraged to work with surrounding area communities in an effort to create new relationships and community building. The residency prioritizes engagement with issues and ideas over the formal production of art works. Residency activities and outcomes are not predetermined, but will be developed by the artist in consultation with

SHA staff and Yesler stakeholders over the period of the residency. Programs developed by artists may include but are not limited to dialogues, performances, social actions, events, temporary art installations, and workshops. Residency activities may take place at various sites around the Yesler neighborhood, including communal indoor and outdoor spaces, gardens, resident buildings, and a mobile art studio dedicated to residency use.

Budget: The Seattle Housing Authority has a \$20,000.00 budget which is inclusive of artist's fees, permits (if applicable), all associated program costs, applicable City of Seattle licensing costs and/or Washington State sales/use tax.

**Scope of Work:**

The Scope of Work is attached as Attachment A hereto.

The Scope of Work is as follows:

The selected Artists shall be asked to perform the following tasks:

- Conduct research related to YT history and culture, including: through resident interviews, meeting with SHA staff, and reviewing available media and materials related to YT and the YT redevelopment project
- Work with SHA staff and planning teams to strategize and fulfill relevant plans for development, implementation, and assessment of artist programs
- Work independently and with SHA staff to initiate, set, and implement project goals, deliverables, schedules, and work plans
- Directly engage YT and surrounding area community members and stakeholders at various points during the planning, implementation, and end phases of their respective projects
- Integrate the interests and preferences of YT residents into all activities as appropriate
- Contribute to supporting activities associated with the overall program of art activities for YT, including a youth media project, comprehensive evaluation program, community celebrations, and other reflection protocols occurring both in progress and at the end of the program term
- Manage administrative aspects of the position as needed, including budgeting and schedule management, submission of proposals and program descriptions to SHA staff over the course of the term of commitment, participating in regular programmatic meetings with coordinating SHA staff, and documenting all project activities from beginning to end.

**Schedule:** It is anticipated that the work will be performed as early as April 2017 and no later than July 2018.

**Anticipated Contract Duration:** SHA expects to execute a Contract for the requested services for the scheduled dates shown above. If necessary, and at SHA's option, time extensions and appropriate scope and compensation adjustments may be made by Change Orders to the Contract.

**Estimated Amount:** The estimated cost for the Contract to be executed based on this solicitation is \$20,0000.

The actual contract that the successful Proposer and SHA will sign will be based on this sample contract. Please be advised that SHA will only negotiate some aspects of the contract. Much of the contents of the sample contract are based on non-flexible requirements and cannot be modified in any form.

- D. Certifications and Assurances Form: In the event that the Contract for these services includes any HOPE VI Revitalization grant funds or any Choice Neighborhood

Implementation (CNI) grant funds, the Consultant shall obtain and submit to SHA a completed and signed Certifications and Assurances Form (copy attached to this solicitation if applicable) for itself and each sub-consultant utilized on the Contract. - E. Payment Requirements: Proposers should be aware that SHA will only make payments on the Contract issued under this solicitation after the work being billed has been completed, and will pay reimbursable expenses only upon receipt of an invoice for the reimbursable expenses. No advanced payments will be made to the proposer, who must have the capacity to meet all project expenses in advance of payments by SHA.
- F. Insurance Requirements: The individual or business selected by SHA will be required to provide acceptable evidence of insurance prior to beginning work. The following summarizes the required insurance coverage. Additional requirements are detailed in the contract that SHA will execute with the selected individual or business. See Section 10 of the standard consultant contract for a complete listing of SHA's standard insurance provisions.

The following insurance coverage(s) / requirements will be required for this project:

- Automobile Liability: \$1,000,000 combined single limit. SHA may make exceptions to the Automobile coverage, depending on the specific needs of the artist and SHA. In select cases, automobile insurance requirements may be waived or adapted.
- G. Criminal Background Investigation: The selected Consultant shall conduct a criminal investigation of all employees, volunteers, subcontractors and sub-consultants performing any work who may reasonably be expected to have direct or incidental contact with SHA residents, SHA staff members, or vulnerable population. In addition, a criminal investigation shall be performed for any person performing work under this Contract who needs special entry into SHA buildings, is given temporary use of an SHA building-access card or who collects payments of any kind. The criminal background investigation shall include, but not necessarily be limited to, a Washington State Patrol background report. In the event a background check provides evidence of a felony conviction within the past seven years, the results of that investigation shall be disclosed to the SHA Project Manager. If any person performing work under this Contract is charged with a felony, the selected Consultant agrees, if requested by SHA, to replace such person with an individual acceptable to SHA.
- H. Diversity: SHA strongly encourages small businesses, minority business enterprises (MBEs), women business enterprises (WBEs), HUD Section 3 businesses, socially and economically disadvantaged businesses and veteran-owned businesses to submit proposals or to participate in this work as sub-consultants.
- I. Rights Reserved by SHA: SHA reserves the right to waive as an informality any irregularities in submittals/proposals, to reject any or all submittals/proposals, and to cancel this solicitation at any time prior to contract award. SHA also reserves the right to award all or any portion of the work specified in this Informal Solicitation to any proposer(s). In order for SHA to make payments to you or to procure goods or services from you, we need the information requested on the Vendor Fact Sheet, which also serves as a substitute IRS W-9 Form. The information about you will be entered into our computerized payment system and will allow us to make required reports to the Federal government about our business and payment transactions.

**Substitute IRS Form W-9 Certification:** In completing the Vendor Fact Sheet, you must sign the "Substitute IRS Form W-9 Certification" or backup withholding will apply.
