# A. INTRODUCTION

- 1) <u>General:</u> The Seattle Housing Authority (SHA) is seeking proposals from qualified Service Providers to assist SHA in providing year-round tutoring and academic assistance to youth living in SHA housing and receiving housing assistance from SHA.
- 2) <u>Seattle Housing Authority Background:</u> SHA is a public body corporate and politic that provides affordable housing to about 34,000 low-income people in Seattle. SHA operates according to the following Mission and Values:

### **Our Mission**

Our mission is to enhance the Seattle community by creating and sustaining decent, safe and affordable living environments that foster stability and increase self-sufficiency for people with low-income.

### Our Values

As stewards of the public trust, we pursue our mission and responsibilities in a spirit of service, teamwork, and respect. We embrace the values of excellence, collaboration, innovation, and appreciation.

The mission of the Seattle Housing Authority is to enhance the Seattle community by creating and sustaining decent, safe and affordable living environments that foster stability and self-sufficiency for people with low incomes. SHA provides long-term, low-income rental housing and rental assistance to more than 34,000 people in Seattle. SHA owns and operates approximately 8,000 units at nearly 400 sites throughout the city. SHA also administers more than 10,000 Housing Choice Vouchers, enabling low-income residents to receive rental assistance throughout the Seattle housing market. SHA, an independent public corporation established in 1939, is governed by a seven-member Board of Commissioners, two of whom are SHA residents. Commissioners are appointed by the Mayor and confirmed by the City Council. More information is available at <a href="https://www.seattlehousing.org">www.seattlehousing.org</a>.

3) Women and Minority Business Enterprise (WMBE) Inclusion Plan: SHA requires proposers to make good-faith efforts to meet SHA's 14% aspirational Inclusion Plan goal in the use of minority-owned and women-owned businesses in the direct performance of commercially useful work as part of the proposed Project Team. Also, SHA requires a good-faith effort in finding and utilizing the services of socially and economically disadvantaged businesse enterprises, HUD Section 3 businesses, small businesses and veteran-owned businesses and to provide meaningful opportunities to those firms to participate in the direct performance of commercially useful work as part of the proposed Project Team.

Also, SHA requires the good-faith efforts to include women, minority, economically disadvantaged, section 3 or other low-income residents in their firm's in-house team makeup for this Contract. This Equal Employment Opportunity (EEO) does not count towards the meeting of the inclusion plan goals, but it could be helpful to evaluators in determining your firm's good-faith efforts.

Good-faith efforts will be considered in the evaluation process for selecting a qualified firm. Please complete **Exhibit A** attached hereto and include it with your Proposal.

4) <u>Cooperative Purchasing:</u> RCW 39.34 allows cooperative purchasing between public agencies (political subdivisions) in the State of Washington. SHA accepts no responsibility for the performance of the successful party in providing services to other public agencies, nor any responsibility for the payment price to the successful party for other public-agency purchases.

Submittal: The deadlines given above are firm as to place, date, and time. SHA will not consider any proposal received after the deadline and will return all such proposals unopened.

All proposals should be clearly marked when delivered or mailed to avoid any confusion about recording arrival dates and times. Proposers should take this practice into account and submit their materials early to avoid any risk of ineligibility caused by unanticipated delays or other delivery problems. NOTE: A faxed or e-mailed proposal is not acceptable.

Upon receipt of each proposal, SHA's Purchasing Division will date-stamp it to show the exact time and date of receipt. Upon request, Purchasing will provide the Proposer with an acknowledgment of receipt. All proposals received will become the property of the Seattle Housing Authority and will not be returned to the Proposer.

**Proposals** should be limited to a maximum of 14 pages single sided, or 7 pages double sided in no smaller than 11 point font on 81/2" by 11" sheets. The following are NOT INCLUDED in the page limit mentioned above: your cover letter, vendor fact sheet, resumes, Section 3 form, Certifications and Representations of Offerors - Non-Construction Contract (form HUD-5369-C), and the Suspension and Debarment Certificate for Consultant. Your cover letter should express your interest in performing the work. A principal or officer of the firm authorized to execute contracts or other similar documents on the firm's behalf must sign the letter.

- 1) Required number of copies: Proposers responding to this RFP shall submit one (1) original and five (5) copies of their proposal to the address indicated above. The following items/forms are to be submitted with the one original proposal **only.** Do not include these items/forms with the proposal copies.

### 2) Proprietary Proposal Material:

Any records or materials submitted to SHA in response to this RFP become public records under Washington State law (see RCW Chapter 42.56, the Public Disclosure Act, at <a href="http://www1.leg.wa.gov/LawsAndAgencyRules">http://www1.leg.wa.gov/LawsAndAgencyRules</a>). Public records must be promptly disclosed upon request unless a statute exempts disclosure.

SHA Solicitation No. 5333 Page 3 of 17 Exemptions from disclosure include trade secrets and valuable formulas (see RCW 42.56 and RCW Ch. 19.108); however, public disclosure exemptions are narrow and specific. Proposers are expected to be familiar with any potentially-applicable exemptions, and the limits of those exemptions.

Proposers are obligated to separately bind and clearly mark as "proprietary" information any proposal records they believe are exempted from disclosure. The body of the proposal may refer to these separately-bound records. Proposers should mark as "proprietary" only that information they believe legitimately fits within a public-disclosure exemption. SHA may reject solicitation responses that are marked proprietary in their entirety.

If SHA receives a public disclosure request for records that a Proposer has marked as "proprietary information," SHA may notify the Proposer of this request and postpone disclosure briefly to allow the Proposer to file a lawsuit under RCW 42.17.330 to enjoin disclosure; however, this is a courtesy of SHA and not an obligation.

SHA has no obligation to assert an exemption from disclosure. If the Proposer believes that its records are exempt from disclosure, the Proposer is obligated to seek an injunction under RCW 42.56. By submitting a proposal, the Proposer acknowledges this obligation; the Proposer also acknowledges that SHA will have no obligation or liability to the Proposer if the records are disclosed.

- 3) <u>Cost of Preparing Proposals:</u> SHA will not be liable for any costs incurred by the Proposer in the preparation and presentation of proposals submitted in response to this RFP including, but not limited to, costs incurred in connection with the Proposer's participation in demonstrations and the pre-proposal conference.
- 4) Rights Reserved by SHA: SHA reserves the right to waive as an informality any irregularities in submittals and/or to reject any or all proposals. SHA requests that companies refrain from requesting public disclosure of selection information until a contract has been executed as a measure to best protect the solicitation process, particularly in the event of a cancellation or re-solicitation. With this preference stated, SHA shall continue to properly fulfill all public disclosure requests for such information as required by State Law.

### C. SCOPE OF WORK

<u>General:</u> The selected Consultant shall assist SHA in providing year-round tutoring and academic assistance to youth living in SHA housing and receiving housing assistance from SHA.

The program shall initially serve children and youth (elementary, middle and high school students) from culturally, ethnically, and economically diverse families, with priority given to residents of the High Point, Jackson Park Village, NewHolly, Rainier Vista and Yesler Terrace communities, as well as for youth living in SHA housing surrounding these communities. Additional locations may be added and/or the program expanded during the Contract period.

<u>Scope:</u> The selected Service Provider shall prepare a strategy that is consistent with the purpose, objectives and general project description as further stated below:

- a. Provides clearly identified program objectives, level of service, and measurable outcomes. Outcomes should include Service Provider-identified outcomes (at least some of which should be in alignment to the Seattle Public Schools' (SPS's) goals for Literacy Super readers) https://www.seattleschools.org/district/district quick facts/strategic plan/priorities a nd goals/instruction and learning experiences/3rd grade reading/seattle super readers and shows an ability to adapt to community/youth/SHA needs. Outcomes should also indicate targets for youth success and/or growth. Proposals will be evaluated on realistic measures that demonstrate real student growth as well as on how well the Service Provider can demonstrate an understanding of which key indicators are important to student growth and can be successfully impacted through their proposed program; data and other information indicating academic and personal growth and achievement that you monitor and track.
- b. Provides information on how to offer culturally, economically, and ethnically diverse youth as described in Scope of Work with programming that meets their specific academic needs;
- Demonstrates sound planning, adequate resources, and sufficient administrative capability to ensure quality and coordination in the delivery of services as described in Scope of Work;
- d. Demonstrates alignment with Seattle Public Schools' Strategic Plan Priority: High-Quality Instruction and Learning Experiences: Educate the whole child¹ through high-quality instruction² and learning experiences that accelerate growth for students of color who are furthest from educational justice, with an intentional focus on African American males.
  - Whole child education goes beyond a focus on academic achievement. When educators focus on educating the whole child, students are healthy, safe, engaged, supported, and challenged. In Seattle Public Schools, this means that we appreciate and serve the academic, social, emotional, and behavioral strengths and needs of students, which we believe comprise the needs of the "whole child."
  - High-quality instruction is focused on student-centered learning and achievement, intentional about student engagement, and aligned to standards with consistent and appropriate feedback.
  - At its foundation, culturally responsive education means that students are in an environment where they have the individual safety and comfort to learn within a classroom that has a common culture that is respectful of all backgrounds.
  - Goals
  - Students of color who are furthest from educational justice will feel safe and welcome in school. Measures Used to Evaluate Success: Student culture and climate surveys; Attendance; Discipline; Equitable access to services (i.e., special education, English language learners, and highly capable).
  - Students of color who are furthest from educational justice will read at grade level by 3rd grade. Measures Used to Evaluate Success: 3rd grade SBA ELA proficiency.

- Students of color who are furthest from educational justice will be proficient in mathematics in 5th grade and 7th grade. Measures Used to Evaluate Success: 5th and 7th grade SBA Mathematics proficiency.
- Students of color who are furthest from educational justice will finish 9th grade on track for on-time graduation. Measures Used to Evaluate Success: At least six credits by the end of 9th grade;
- Students of color who are furthest from educational justice will graduate ready for college and career. Measures Used to Evaluate Success: SBA; SAT / ACT; Advanced coursework completion; CTE course pathway completion; College enrollment without developmental courses.
- e. Proposal includes plans to gain access to school-based academic data for participants and to track and respond to Seattle Public Schools and SHA-identified indicators of success. Proposal includes details of which data points are currently tracked by the Service Provider as well as any additional data that the Service Provider intends to track as part of the proposed program. Proposal demonstrates how the data will be used to help youth improve their academic outcomes. (see examples of indicators in Scope of Work.) SHA is committed to assisting contracted Service Providers with this process. SHA will help the selected Service Provider access any required, base-line data, and will support access to trainings for the Service Provider to be able to understand and use the data. Once the data is available, the selected Service Provider will need the capacity to monitor and utilize this data to inform the type of services offered within the program as a whole as well as to individual youth based on their specific academic needs. (A Data Sharing Agreement between the selected Service Provider, SHA and/or the SPS may be required in this process depending on types and amount of data shared);
- f. Proposal includes information indicating academic and personal growth/achievement information that the Service Provider will track or monitor including details of how the information is used and projected results.
- g. Proposal includes academic activities that are realistic, attainable, and of interest to targeted youth;
- h. Proposal focuses resources on youth in need of academic support, with an emphasis on giving strong support to those who are most struggling;
- i. Proposal includes specific recruitment methods to recruit and retain at least 425 academically at risk youth from the diverse cultural, ethnic and economic populations in the five communities listed in Scope of Work. Proposal includes specific recruitment and support methods for limited English-speaking youth;
- Proposal includes a plan to reach out to the communities identified in the Scope of Work and indicates a willingness to offer services to youth referred through SHA systems which may include SPS referrals;
- k. Proposal includes a clear plan to develop and address a waiting list, including ways to support more youth as interest allows, to partner with other organizations to help wait-listed youth, and to target the youth who most need support;

- I. Proposal includes a plan for tracking referrals to other tutoring programs when necessary;
- m. Proposal includes plans to adapt program as needed to meet SHA community and education goals;
- n. Proposal includes active participation by Service Provider staff at community events and at community meetings made up of staff members from other service providers who offer services for the identified communities:
- o. Proposal includes partnerships with other service providers to maximize resources and implement the best possible programming for youth;
- p. Proposal includes a system to determine successful participants and have them transition out of the program, or to use less resources within the program so as to offer space and resources for youth in greater need of academic support;
- q. Proposal clearly describes how Service Provider will ensure that program services are offered to a diverse student population (including diversity of ethnicity, religion, culture, and academic need);
- r. Proposal includes a clear plan of how to recruit and retain a diverse group of volunteers to meet program and student needs. Include in this section any specific plans to recruit youth and/or adult volunteers from the SHA communities served. Also include plans for volunteer background checks and training.
- s. Proposal includes plans to offer services on-site within each community, and plans to access space in each community if the agency or organization does not already rent/own space in the communities identified in Scope of Work.

Emphasis is to be placed on the 2020 calendar year. The estimated range of funding for services for the Contract to result from this Request for Proposals (RFP) is between \$270,000 and \$291,734 for a pro-rated nine-month period from April 1, 2020 through December 31, 2020. SHA may commit additional funding for the youth tutoring services for subsequent years, depending on program performance and available funding.

# D. <u>INFORMATION TO BE PROVIDED IN YOUR PROPOSAL</u>

**Response / Proposal Content:** To facilitate evaluation, proposals should address and be organized in the order of the outline given below and include the following information:

- Cover Letter
- Address each of the evaluation criteria below:
  - Relating to Criterion 1: Firm's Experience with Tutoring and Academic Assistance with Youth Experience of the firm with tutoring and academic assistance to: elementary students (worth a maximum of 10 points); middle school students (worth a maximum of 10 points); and high school students (worth a maximum of 10 points) (for a total maximum of 30 points).

- Relating to Criterion 2: Proposed Program Design Submit a program design that demonstrates how you will perform the tasks outlined in the Scope of Work above. (worth a maximum of 40 points).
- **Relating to Criterion 3: Program Evaluation:** Describe a plan for program evaluation, using specific measurement tools and participant surveys. The evaluation component should include a strategy to access, track and report on student grades and academic testing records for students attending Seattle Public Schools. (worth a maximum of 20 points).
- Relating to Criterion 4: Experience and Expertise of the Personnel to be Assigned: Experience of the personnel to be assigned to perform this work with elementary students (worth a maximum of 10 points); middle school students (worth a maximum of 10 points); and high school students (worth a maximum of 10 points) (for a total maximum of 30 points).

Please submit an organizational chart, resumes of key staff identified to be assigned to this effort, and job descriptions showing staffing expectations, including:

- a. Level of educational attainment:
- b. Experience in the administration of youth tutoring and leadership programming;
- c. Experience in direct academic support for youth;
- d. Experience in data management and program evaluation;
- e. Experience in recruiting and retaining culturally, and economically diverse volunteers and students;
- f. Ability to work effectively with low-income youth and families as well as with culturally, ethically, and racially diverse populations, especially those who do not speak English as a first language.
- Relating to Criterion 5: Proposed Budget, Including Match and Funding from Non-SHA Sources: Submit a proposed line-item budget which reflects accuracy, reasonableness, and completeness of proposed costs, plus the level of funding the Service Provider can contribute to the program through other financial and inkind resources. Include experience in raising necessary funds and resources. Costs for renting space to provide these services should be included in the budget, including a description of space for services. (worth a maximum of 15 points).
- Provide resumes for the key personnel named in your response.
- <u>Include a list of at least three references</u> for whom the firm or team members have performed similar work in the last five years (including agency or business name of client, contact person, address, telephone number and e-mail address if available.)

# E. CONSULTANT EVALUATION CRITERIA

Consultants' submittals will be evaluated based on the criteria listed in this section and further described in Section D above. In preparing the submittal to SHA, it is important for proposers to clearly demonstrate their expertise in the areas described in this document. Because multiple areas of expertise are required for successfully performing this project, the Consultant, either through in-house staff or sub-consultants, must demonstrate

expertise and have available adequate numbers of experienced personnel in all of the areas described.

Consultants are encouraged to identify and clearly label in their submittal how each criterion is being fully addressed. Evaluation of responses to this RFP will be based only on the information provided in the submittal package, and if applicable, interviews, and reference responses. SHA reserves the right to request additional information or documentation from the firm regarding its submittal documents, personnel, financial viability, or other items in order to complete the selection process. In submitting a proposal, the Consultant and any sub-consultants agree that any costs, prices, hourly rates proposed shall be valid for a minimum of 90 days from the proposal due date.

The following criteria with a point system of relative importance with an aggregate total of one hundred thirty-five (135) points will be utilized to evaluate the qualifications of each proposer:

## F. SELECTION PROCESS

An evaluation panel will rate all responses to this RFP that are received on or before the stated deadline, according to the criteria listed above. Based on its initial evaluation, the panel may:

- 1. Make a recommendation to SHA's Executive Director and request authority to negotiate a Contract with one or more proposers; or
- 2. Request additional information from the proposer or proposers whose responses appear to have the greatest likelihood of success; and/or
- 3. Invite one or more proposer whose responses appear to have the greatest likelihood of success to attend an interview/presentation to discuss their proposal; and then make a recommendation to SHA's Executive Director and request authority to negotiate a contract with one or more proposers.

SHA reserves the right to conduct reference checks, at any time during the evaluation process:

In the event that information obtained from the reference checks reveals concerns about any proposer's past performance and their ability to successfully perform the contract to be executed based on this RFP, SHA may, at its sole discretion, determine that the Proposer is not a responsible proposer and may select the next highest-ranked Proposer whose reference checks validate the ability of the Proposer to successfully perform the contract to be executed based on this RFP. In conducting reference checks, SHA may include itself as a reference if the Proposer has performed work for SHA, even if the Proposer did not identify SHA as a reference.

By submitting its proposal in response to this RFP, the consultant accepts the procurement method used and acknowledges and accepts that the evaluation process will require subjective judgments by SHA and the evaluation panel.

Any protest of the selection process shall be resolved in accordance with SHA's Procurement Policies, which may be reviewed at the following web site address:

## G. CONTRACT NEGOTIATIONS

SHA shall negotiate with the most qualified Proposer or Proposers, as determined by evaluation of the responses and, if applicable, interviews. If SHA is unable to reach agreement with any of the highest ranked firms, it may negotiate with the next highest ranked firm or firms, proceeding in turn to each firm that SHA has determined to be qualified, in order of rank. If agreement cannot be reached with any qualified firm, SHA reserves the right to cancel the solicitation.

SHA expects to execute one or more Contracts for services for one year. At SHA's option, a Change Order may be executed extending the Contract(s) for up to four additional one-year periods, along with appropriate adjustments in the scope of work and compensation.

# H. ADMINISTRATIVE INFORMATION

- 1) Small and/or Disadvantaged Business Enterprise Requirements: SHA strongly encourages minority-owned and women-owned businesses, socially and economically disadvantaged business enterprises, HUD Section 3 businesses, small businesses and veteran-owned businesses to submit proposals, to participate as partners, or to participate in other business activity in response to this RFP. As outlined in more detail in Section A,3), SHA has also included a 14% Women and/or Minority Business Enterprise (WMBE) aspirational participation goal. Consequently, in responding to the solicitation, submitters must include the attached Exhibit A SHA Inclusion Plan demonstrating good faith efforts in seeking meaningful opportunities for WMBEs in the work of the Contract.
- 2) <u>Section 3 Requirements:</u> Section 3 of the Housing and Urban Development Act of 1968 (hereinafter "Section 3") requires SHA to the greatest extent feasible to provide employment opportunities to Section 3 residents. Section 3 residents include residents of SHA communities and other low-income residents of Seattle. Each

Proposer is required to submit with their one original proposal, the Section 3 Business Certification and Resident Employment Plan form.

- A. <u>Section 3 Contract Language:</u> The following language regarding Section 3 will be included as part of the contract to be executed based on this RFP.
  - 1. The work to be performed under this contract is subject to the requirements of Section 3 of the Housing and Urban Development Act of 1968, as amended, I 2 U.S.C. 1701u (Section 3). The purpose of Section 3 is to ensure that employment and other economic opportunities generated by HUD assistance or HUD-assisted projects covered by Section 3, shall, to the greatest extent feasible, be directed to low- and very low-income persons, particularly persons who are recipients of HUD assistance for housing.
  - 2. The parties to this contract agree to comply with HUD's regulations in 24 CFR part 135, which implement Section 3. As evidenced by their execution of this contract, the parties to this contract certify that they are under no contractual or other impediment that would prevent them from complying with the part 135 regulations.
  - 3. The contractor agrees to send to each labor organization or representative of workers with which the contractor has a collective bargaining agreement or other understanding, if any, a notice advising the labor organization or workers representative of the contractors commitments under this Section 3 clause, and will post copies of the notice in conspicuous places at the work site where both employees and applicants for training and employment positions can see the notice. The notice shall describe the Section 3 preference, shall set forth minimum number and job titles subject to hire, availability of apprenticeship and training positions, the qualifications for each; and the name and location of the person(s) taking applications for each of the positions; and the anticipated date the work shall begin.
  - 4. The contractor agrees to include this Section 3 clause in every subcontract subject to compliance with regulations in 24 CFR part 135, and agrees to take appropriate action, as provided in an applicable provision of the subcontractor in this Section 3 clause, upon a finding that the subcontractor is in violation of the regulations in 24 CFR part 135. The contractor will not subcontract with any subcontractor where the contractor has notice or knowledge that the subcontractor has been found in violation of the regulations in 24 CFR part 135.
  - 5. The contractor will certify that any vacant employment positions, including training positions, that are filled (1) after the contractor is selected but before the contract is executed, and (2) with persons other than those to whom the regulations of 24 CFR part 135 require employment opportunities to be directed, were not filled to circumvent the contractors obligations under 24 CFR part 135.
  - 6. Noncompliance with HUD's regulations in 24 CFR part 135 may result in sanctions, termination of this contract for default, and debarment or suspension from future HUD assisted contracts.

- 3) Basic Eligibility: By submitting for this Solicitation:
  - A. Proposer represents that it is licensed to do business in the State of Washington and it has a state Unified Business Identifier (UBI) number.
  - B. Proposer represents by its submission of the SUSPENSION AND DEBARMENT COMPLIANCE CERTIFICATE FOR CONSULTANT form, attached hereto, that neither it nor it principals/officers are presently debarred, suspended, proposed for debarment, or declared ineligible or voluntarily excluded from participation in this transaction by any federal department or agency. Proposer further represents that by submitting a Proposal and being selected for this work, that it will comply with the requirements regarding sub-contracting and the purchase of supplies or materials for this work and the sub-contractors and/or firms, and their principals/officers are not debarred or otherwise disqualified from doing business with SHA. The Proposer understands that if selected, it shall provide evidence with the SUSPENSION AND DEBARMENT COMPLIANCE CERTIFICATE FOR SUB-CONSULTANTS form attached to this RFP of Proposer's sub-contractors' (if applicable) eligibility.
  - C. Certification and Representations of Offerors Form: The Consultant shall submit to SHA a completed and signed Certifications and Representations of Offerors form (HUD-5369-C) (attached hereto) for itself.
- 4) Payment Requirements: Proposers should be aware that SHA will only make payments on the contract issued under this RFP after the work being billed has been completed, and within 30 calendar days of receipt of a properly prepared and SHA approved invoice from the Consultant. Supporting documentation is required for payment of reimbursable expenses. No advance payments will be made to the Consultant, who must have the capacity to meet all project expenses in advance of payments by SHA.
- **5)** Approval of Sub-Consultants: SHA retains the right of final approval of any sub-consultant of the selected Proposer who must inform all sub-consultants of this provision.
- 6) <u>Documents Produced:</u> All reports and other documents produced under contract to SHA must be submitted to SHA in hard copy and/or a digital format that meets SHA's requirements, using Microsoft Office products in an IBM-compatible format. All documents and products created by the Consultant and their sub-consultants shall become the exclusive property of SHA.
- 7) Other Contracts: During the original term and all subsequent renewal terms of the contract resulting from this RFP, SHA expressly reserves the right, through any other sources available, to pursue and implement alternative means of soliciting and awarding similar or related services as described in this RFP.
- **8)** Funding Availability: By responding to this RFP, the Proposer acknowledges that for any contract signed as a result of this RFP, the authority to proceed with the work is contingent upon the availability of funding.
- 9) <u>For-Profit Subgrantee and Contractor Certifications and Assurances Form:</u> In the event that the Contract for these services includes any Federal Grant Funds, the Consultant must submit a completed and signed Certifications and Assurances Form

(copy attached to this RFP) for itself and each sub-consultant, if known will be utilized on the Contract. Such form shall be submitted to SHA with the one original submittal for this RFP.

10) <u>Contract Requirements:</u> Proposers may review a sample of SHA's standard contract language that will form the basis for any contract executed based on this solicitation by visiting the following link:

SHA's standard contract document is intended to guide you in developing your proposal. The actual contract that the successful Proposer and SHA will sign will be based on this sample contract. Please be advised that SHA will only negotiate some aspects of the contract. Much of the contents of the sample contract are based on non-flexible requirements and cannot be modified in any form.

In addition to any SHA-owned properties that may be included in the scope of work of this solicitation, there may be other properties for which SHA serves as General and Managing Partner. These properties are Low-Income-Housing Tax Credit limited partnerships. If any of these Limited Partnership (LP) properties are included in the scope of work under this solicitation, the selected firm must also name those LP's as additional insureds to their policy under the required insurance coverages described under Section H. 11C. below. The Contract(s) resulting from this solicitation must also be entered into by SHA, the selected firm, and all legal entities, including the LPs if applicable.

SHA may also be acting as an agent to Condominium or other Associations that are associated with the SHA or LP properties included in the scope of work for this solicitation. If so, the contract(s) resulting from this solicitation will be between the selected firm and the applicable Association.

**11)**<u>Insurance:</u> The following are the insurance requirements that will be included in the contract executed based on this RFP:

Within seven (7) days from the date of the Notice of Award, and prior to commencement of the Work, Consultant shall obtain all the insurance required by the Contract Documents and provide evidence satisfactory to Owner that such insurance has been procured. Review of the Consultant's insurance by Owner shall not relieve or decrease the liability of Consultant.

Failure of the Consultant to fully comply with the insurance requirements of this Contract will be considered a material breach of contract and, at the option of Owner, will be cause for such action as may be available to Owner under other provisions of this Contract or otherwise in law, including immediate termination of the Contract.

### A. General Insurance Requirements:

1. Prior to undertaking any work under this Contract, the Consultant shall procure and maintain continuously for the duration of this Contract, at no expense to

Owner, insurance coverage as specified below, in connection with the performance of the work of this Contract by the Consultant, its agents, representatives, employees and/or subcontractors (the term subcontractors as used in this Contract shall include sub-consultants). Review of the Consultant's insurance by Owner shall not relieve or decrease the liability of Consultant.

- 2. The Consultant's insurance shall be primary as respects Owner, and any other insurance maintained by Owner shall be excess and not contributing insurance with the Consultant's insurance.
- 3. Except with respect to the limits of insurance, and any rights or duties specifically assigned to the first named insured, the Consultant's Commercial General Liability and Commercial Automobile Liability insurance coverage shall apply as if each named insured were the only named insured, and separately to each insured against whom claim is made or suit is brought.
- 4. Insurance policies, deductibles, self-insured retentions, and insurance carriers will be subject to review and approval by Owner. Except for Professional Liability Insurance coverage, if applicable, each insurer must either be 1) authorized to do business in the State of Washington and maintain A.M. Best's ratings of "A VII" or higher, or 2) procured as surplus lines under the provisions of RCW Chapter 48.15 ("Unauthorized Insurers"), except as may be otherwise approved by the Owner. Insurers or reinsurers of Professional Liability (Errors and Omissions) Insurance must have a rating of "B+VII or higher.
- B. <u>Insurance Coverage and Terms:</u> The following are the types and amounts of insurance coverage that must be maintained by the Consultant during the term of this Contract. The Consultant must provide acceptable evidence of such coverage prior to beginning work under this Contract. Consultant shall maintain the following insurance coverage for the duration of the contract and for one (1) year after final completion.
  - Commercial General Liability Insurance. Commercial General Liability (CGL) insurance including bodily injury, property damage, and products/completed operations, written on an occurrence form, with the following minimum coverage:

\$1,000,000 each occurrence, and

\$2,000,000 aggregate

Coverage shall extend to cover the use of all equipment on the site or sites of the work of this Contract. In the event that the services to be provided under this Contract involve the Consultant's contact with minor children, and/or elderly, disabled or vulnerable adults as defined in RCW 74.34.020, the Consultant shall provide evidence that sexual misconduct coverage has not been excluded from the policy and is covered under the policy. Acceptable evidence of sexual misconduct coverage must include an endorsement and policy excerpt(s) and is subject to approval by Owner's Risk Manager.

2. <u>Employers Liability or Washington Stop Gap Liability.</u> A policy of Employers Liability or a Washington Stop Gap Liability insurance endorsement with the following minimum coverage:

# \$1,000,000 each accident/disease

3. <u>Commercial Automobile Liability Insurance.</u> A policy of Commercial Automobile Liability Insurance, including coverage for owned, non-owned, leased or hired vehicles written on an insurance industry standard form (CA 00 01) or equivalent, with the following minimum coverage:

# \$1,000,000 combined single limit (CSL) coverage

- 4. Workers Compensation. A policy of Workers Compensation. As respects Workers Compensation insurance in the State of Washington, the Consultant shall secure its liability for industrial injury to its employees in accordance with the provisions of Title 51 of the Revised Code of Washington (RCW). If the Consultant is qualified as a self-insurer in accordance with Chapter 51.14 RCW, the Consultant shall so certify by a letter signed by a corporate officer, indicating that it is a qualified self-insured, and setting forth the limits of any policy of excess insurance covering its employees, or any similar coverage required.
- 5. <u>Cyber Liability:</u> When applicable, the Consultant shall provide Cyber Liability coverage including both first and third party coverage, covering claims involving privacy violations, information theft, damage to or destruction of electronic information, intentional and/or unintentional release of private information, alteration of electronic information, extortion and network security.

# \$1,000,000 each Occurrence

- C. Owner As Additional Insured: All liability policies except Professional Liability and Workers Compensation shall be endorsed to include Owner and any of Owner's entities (i.e., Limited Partnerships and Associations that are included in the Contract) as additional insured on a primary and non-contributory basis for Work performed in accordance with the Contract documents, and all insurance certificates shall evidence the Owner as additional insured.
- D. <u>Waiver of Subrogation</u>: Consultant's policy shall provide waiver of subrogation by endorsement or otherwise.
- E. <u>Deductibles or Self-Insured Retention:</u> Any deductibles or self-insured retentions \$25,000 or higher must be declared to, and approved by the Owner. The deductible and/or self-insured retention of the policies shall not limit or apply to the Consultant's liability to the Owner. Payment of deductibles shall be the responsibility of the Consultant.
- F. No Limitation of Liability The limits of liability specified herein are minimum limits only. Such minimum limits of liability requirements shall not be construed to limit

the liability of the Consultant or of any of their respective insurers. The Consultant shall include the Owner as an additional insured for primary and non-contributory limits of liability for the full valid and collectible limits of liability maintained by the Consultant whether such limits are primary, excess, contingent or otherwise. This provision shall apply regardless of whether limits maintained by the Consultant are greater than the minimum limits required by this Contract, and regardless of whether the certification of insurance by the Consultant specifies lower minimum limits than those specified for or maintained by the Consultant.

# G. Proof of Insurance and Insurance Expiration:

- 1. The Consultant shall furnish certificates of insurance and policy endorsements as evidence of compliance with the insurance requirements of the Contract. Such certificates and endorsements must be signed by a person authorized by that insurance company to bind coverage on its behalf.
- The Owner must be included as an Additional Insured on a primary and noncontributory basis on all Commercial General Liability and Automobile Liability policies of the Consultant. As respects the CGL insurance such additional insured status shall be evidenced by an ISO endorsement form CG2010 or equivalent.
- 3. As respects CGL insurance such Additional Insured status shall contain a "separation of insureds" provision.
- 4. The Consultant shall include all sub-consultants at any tier as insureds under its policies (except for Professional Liability insurance) and ensure that the Consultant's coverage of sub-consultants under the Consultant's policies is not excluded by any policy provision or endorsement. Alternatively, the Consultant shall:
  - a.) Obtain from each sub-consultant not insured under the Consultant's policy or policies of insurance, evidence of insurance meeting all the requirements of this Contract, and
  - b.) Maintain such evidence on file for a period of one (1) year after the completion of this Contract and, upon request, submit such evidence to SHA for examination.
- 5. The Consultant's insurance shall not be reduced or canceled without forty-five (45) days prior written notice to Owner, except for cancellation for nonpayment of premium, which notice shall not be less than ten (10) days prior to such date, unless a longer period of written notice is required under the provisions of Revised Code of Washington (RCW 48.18.290). The Consultant shall not permit any required insurance coverage to expire during the term of this Contract.
- 6. Owner reserves the right to require complete, certified copies of all required insurance policies at any time during the term of this Contract, or to waive any of the insurance requirements of this Contract at its sole discretion.

H. Criminal Background Investigation: The Consultant shall conduct a criminal background investigation of all employees, volunteers, subcontractors and subconsultants performing any work who may reasonably be expected to have direct or incidental contact with SHA residents, SHA staff members, or vulnerable population. In addition, a criminal background investigation shall be performed for any person performing work under this Contract who is given use of an SHA building-access card or who collects payments of any kind. The criminal background investigation shall include, but not necessarily be limited to, a Washington State Patrol background report or if the employee, volunteer, subcontractor or sub-consultant resides in a state other than Washington, the background report should be obtained from the state patrol office where the employee, subcontractor or sub-consultant has resided for the last 3 years. In the event a background check provides evidence of a felony conviction that information shall be provided to the SHA Project Manager. If any person performing work under this Contract is charged with a felony, the Consultant agrees to remove that person from performing any further work on the project unless and until SHA agrees in writing to allow the person to continue.

The information about you will be entered into our computerized payment system and will allow us to make required reports to the Federal government about our business and payment transactions.

**Substitute IRS Form W-9 Certification:** In completing the Vendor Fact Sheet, you must sign the "Substitute IRS Form W-9 Certification" or backup withholding will apply. If you are subject to backup withholding and you are merely providing your correct taxpayer identification number to SHA, you must cross out the portion of the certification after the word "and" in line two, through the end of line five, before signing the form.
