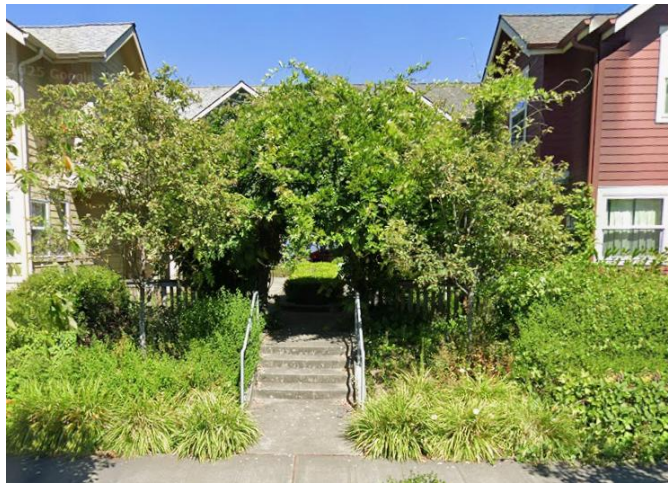

Response: *The pruning of all overhead vegetation structures should be in the scope of work.*

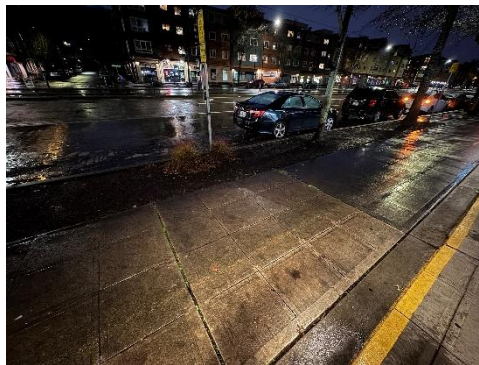
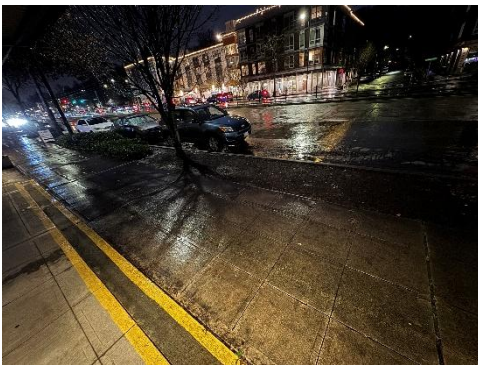
Question 2. Is there a required or preferred frequency for routine landscape maintenance, or should bidders propose a recommended schedule?
