Your Day Care FSA

As a parent you have access to a daycare FSA through Navia. A Daycare FSA allows you to put aside tax-free dollars to pay for child care. FSA funds can be used on daycares, preschools, nannies and more.

Frequently Asked Questions

How much money should I set aside?

The IRS allows \$10,500 per family to be elected under the DCFSA. One person can elect for the entire \$10,500 or the amount can be split between spouses. The accounts are always money-in, money-out, like a bank account. You can only be reimbursed up to the amount you have contributed – they are not prefunded like HCFSAs.

How can I state a qualifying event and sign up outside of open enrollment?

When you have a qualifying life event such as a new birth or adoption – you have 30 days to report your change in status to your benefits department.

What can I use my DCSFA dollars on?

You can use your DCFSA benefits to pay for daycares, preschools, day camps and after school programs.

How do I sign in to my Navia account?

Sign into your Navia account by visiting www.navia.com and selecting login

How can I submit a claim?

Login to your Navia account, and look under the "My Tools" tab to access the online claim submission tool.
