#### A. INTRODUCTION

- 1) **General:** The Seattle Housing Authority (SHA) is seeking a qualified professional firm to provide on-call hazmat services. The Service Provider shall provide Industrial Hygiene Services as requested. The Service provider shall be solely responsible for obtaining/providing all materials, equipment, supplies, labor, and other services required by the Contract as may be necessary to fulfill the requirements of the Contract. The Service Provider shall competently and efficiently supervise and direct activities necessary to fulfill the requirements of the contract, except as otherwise directed by Owner's Project Manager. The Service Provider shall accomplish all services in a timely and appropriate manner, and, at no additional expense to SHA, comply with all applicable laws affecting performance of the Contract, including but not limited to all federal and state laws, county, and city ordinances, Environmental or Safety Laws, implementing regulations, and governmental orders, permits, licenses, approvals, and authorizations. This Contract is for lab testing. The Service Provider will not be drawing conclusions from test results.
- 2) Seattle Housing Authority Background: SHA is a public body corporate and politic that provides affordable housing to about 34,000 low-income people in Seattle. SHA operates according to the following Mission and Values:

Your **cover letter** should express your interest in performing the work. A principal or officer of the firm authorized to execute contracts or other similar documents on the firm's behalf must sign the letter.

#### 2) Proprietary Proposal Material:

Any records or materials submitted to SHA in response to this RFP become public records under Washington State law (see RCW Chapter 42.56, the Public Disclosure Act, at http://www1.leg.wa.gov/LawsAndAgencyRules). Public records must be promptly disclosed upon request unless a statute exempts disclosure. Exemptions from disclosure include trade secrets and valuable formulas (see RCW 42.56 and RCW Ch. 19.108); however, public disclosure exemptions are narrow and specific. Proposers are expected to be familiar with any potentially applicable exemptions, and the limits of those exemptions.

Proposers are obligated to separately bind and clearly mark as "proprietary" information any proposal records they believe are exempted from disclosure. The body of the proposal may refer to these separately bound records. Proposers should mark as "proprietary" only that information they believe legitimately fits

If SHA receives a public disclosure request for records that a Proposer has marked as "proprietary information," SHA may notify the Proposer of this request and postpone disclosure briefly to allow the Proposer to file a lawsuit under RCW 42.17.330 to enjoin disclosure; however, this is a courtesy of SHA and not an obligation.

SHA has no obligation to assert an exemption from disclosure. If the Proposer believes that its records are exempt from disclosure, the Proposer is obligated to seek an injunction under RCW 42.56. By submitting a proposal, the Proposer acknowledges this obligation; the Proposer also acknowledges that SHA will have no obligation or liability to the Proposer if the records are disclosed.

- 3) Cost of Preparing Proposals: SHA will not be liable for any costs incurred by the Proposer in the preparation and presentation of proposals submitted in response to this RFP including, but not limited to, costs incurred in connection with the Proposer's participation in demonstrations and the pre-proposal conference.
- 4) Rights Reserved by SHA: SHA reserves the right to waive as an informality any irregularities in submittals and/or to reject any or all proposals. SHA requests that companies refrain from requesting public disclosure of selection information until a contract has been executed as a measure to best protect the solicitation process, particularly in the event of a cancellation or re-solicitation. With this preference stated, SHA shall continue to properly fulfill all public disclosure requests for such information as required by State Law.

#### C. SCOPE OF WORK

The Service Provider shall provide Industrial Hygiene Services as requested. The Service provider shall be solely responsible for obtaining/providing all materials, equipment, supplies, labor, and other services required by the Contract as may be necessary to fulfill the requirements of the Contract. The Service Provider shall competently and efficiently supervise and direct activities necessary to fulfill the requirements of the contract, except as otherwise directed by Owner's Project Manager. The Service Provider shall accomplish all services in a timely and appropriate manner, and, at no additional expense to SHA, comply with all applicable laws affecting performance of the Contract, including but not limited to all federal and state laws, county, and city ordinances, Environmental or Safety Laws, implementing regulations, and governmental orders, permits, licenses, approvals, and authorizations.

This Contract is for lab testing. The Service Provider will not be drawing conclusions from test results.

Such services shall include, but not limited to the following:

1. Air monitoring and analysis of airborne contaminants including, but not limited to, dust, vapors, fumes, paint overspray, asbestos and pesticides in various locations including, office buildings, field locations shops, substations, and hydroelectric

The Service Provider may offer suggestions on how monitoring should be conducted, numbers and types of samples, specific contaminants to look for, where samples should be taken, etc. However, the responsibility and final decision on such matters rest with SHA's Project Manager. The Service Provider may be required to provide monitoring services on weekends or after regular business hours.

- 2. Onsite surveys including, but not limited to, ventilation systems, indoor air quality, noise abatement, asbestos abatement and/or non-ionizing radiation.
- 3. Onsite sampling and laboratory testing for chemical, physical and/or biological hazards.
- 4. Onsite analysis of ergonomic problems in office or fieldwork settings within limits described by the Safety and Health Specialist.
- 5. Quantitative or qualitative respirator tests.
- 6. Asbestos and Hazardous Material Training
- 7. The Service Provider may subcontract some of the work to another industrial hygiene firm with written concurrence from SHA's Project Manager in the event the Contractor is unable to provide the needed services within the requested timeframe.
- 8. Services will be performed within the Seattle area.
- 9. The Service Provider may be requested, from time to time, to provide certified industrial hygienists to perform certain jobs or types of work.

The Service Provider shall also provide Facility Environmental Survey and Assessment Services, on an as-needed basis, in the following areas:

- a. Building Surveys (Line Items 1-3)
  - 1. Asbestos AHERA Inspector
  - 2. Lead Paint Survey
  - 3. Complete Building Contaminant
- b. Soils & Sediments (Line Items 4-6)
  - 1. Site tech: Soils Contaminant Survey 1a. Cert Lead Inspector
  - 2. PH I Environmental Site Survey
  - 3. PH II Environmental Site Survey
- c. Items Excluded
  - 1. EXPENSES: Expenses are site-specific and must be agreed upon with SHA. An itemized site-specific list of all proposed expenses (rentals, laboratory fees, equipment, supplies) will be provided as part of each Work Order. Freight and delivery costs will also be included in the itemized list.

- 2. LABORATORY ANALYSIS COST: Laboratory analysis fees are part of the itemized expense list provided to SHA for specific site work. The analysis media, matrix, protocols, and number of samples taken will be discussed with SHA's Project Manager and agreed upon for specific sites via the Work Order. Laboratories used by the Consultant will also be screened by SHA for credentials and current certifications for the contaminant(s) sampled.
- 3. IN-HOUSE INSPECTION REPORT REVIEWS: The certified inspector for each discipline is expected to be experienced and capable of review and sign-off of their own inspection reports. Inhouse quality control reviews by other members of the Service Provider or consulting for the Service Provider are at the company's expense and should not be itemized as an expense payable by SHA.
- 4. ASSESSMENTS OF DATA COLLECTED: Assessments and analysis of data that is not covered must be negotiated separately.

#### a. COMPLIANCE AND PERMITS

The Service Provider shall accomplish all services in a timely and appropriate manner, and at no additional expense to SHA, shall comply with all applicable laws affecting performance of the Contract, namely all federal, state, and local laws, and county and city ordinances.

The Contractor shall have and maintain current and in full force and effect during the term of the Contract all licenses, permits and other governmental approvals or authorizations required by all applicable Environmental or Safety Laws, implementing regulations, and governmental orders, permits, licenses, approvals, and authorizations and shall comply with all requirements, thereof.

The Contractor's laboratory services shall have American Industrial Hygienist Association (AIHA) and/or National Voluntary Lab Accreditation Program (NVLAP) accreditation.

The Contractor is solely responsible for its own compliance. Nothing in the Contract shall excuse noncompliance including SHA's knowledge or receipt, review, acceptance or approval of the Contractor's permits, licenses, governmental approvals or authorizations, insurance documentation, safety plans, other plans or other regulatory or compliance information.

#### b. REPORT AND RECORDS

The term, "report", means documentation in support of the sample results, such as lab and field notes, unless otherwise stipulated. More specifically, reports generally will include the following:

1. Exposure levels on an eight-hour (8) time-weighted average and short-term exposure limits bases, as defined by the WAC, if applicable.

- 2. A comparison to WAC permissible exposure limits for contaminant evaluated.
- 3. Recommendations on administrative controls, personal protective equipment. engineering controls and/or modifications to work practices within the report.
- 4. Shall contain the names and job titles of all individuals monitored along with their personal exposure level.
- 5. The Service Provider shall provide verbal confirmation to SHA's Project Manager within forty-eight (48) hours of the sampling date or twenty-four (24) hours for rush written confirmation within seven (7) davs.

#### c. PROGRESS MEETINGS

Upon periodic request by SHA, the Service Provider shall meet with SHA's Project Manager to discuss the status of services provided by the Service Provider. The Service Provider shall also be available for in-person meetings with all appropriate personnel present to discuss any service-related problems and/or possible contract violations.

#### d. PAYMENT

Bid prices shall remain firm through the initial year of the Contract. On each anniversary of the contract execution during the Contract Term, the prices are adjusted to the lesser of (a) a price mutually agreed upon between SHA and Service Provider, or (b) the proportionate cumulative increase (or decrease) in the CPI, if any, during the previous Contract Year. For purposes of this section, CPI means the United States Department of Labor, Bureau of Labor Statistics, All Urban Consumers, not seasonally adjusted, database code CUUR0000SA0, or if such index is no longer published, a successor or substitute index designated by SHA

#### D. INFORMATION TO BE PROVIDED IN YOUR PROPOSAL

#### **E. CONSULTANT EVALUATION CRITERIA**

Consultants' submittals will be evaluated based on the criteria listed in this section and further described in Section D above. In preparing the submittal to SHA, it is important for proposers to clearly demonstrate their expertise in the areas described in this document. Because multiple areas of expertise are required for successfully performing this project, the Consultant, either through in-house staff or sub-consultants, must demonstrate expertise and have available adequate numbers of experienced personnel in all of the areas described.

Consultants are encouraged to identify and clearly label in their submittal how each criterion is being fully addressed. Evaluation of responses to this RFP will be based only on the information provided in the submittal package, and if applicable, interviews, and reference responses. SHA reserves the right to request additional information or documentation from the firm regarding its submittal documents, personnel, financial viability, or other items in order to complete the selection process. In submitting a proposal, the Consultant and any sub-consultants agree that any costs, prices, hourly rates proposed shall be valid for a minimum of 90 days from the proposal due date.

The following criteria with a point system of relative importance with an aggregate total of one hundred (must match the Total Maximum Points for Qualifications in table below) points will be utilized to evaluate the qualifications of each proposer:

#### F. <u>SELECTION PROCESS</u>

An evaluation panel will rate all responses to this RFP that are received on or before the stated deadline, according to the criteria listed above. Based on its initial evaluation, the panel may:

- 1. Make a recommendation to SHA's Executive Director and request authority to negotiate a Contract with one or more proposers; or
- 2. Request additional information from the proposer or proposers whose responses appear to have the greatest likelihood of success; and/or
- 3. Invite one or more proposer whose responses appear to have the greatest likelihood of success to attend an interview/presentation to discuss their proposal; and then make a recommendation to SHA's Executive Director and request authority to negotiate a contract with one or more proposers.

SHA reserves the right to conduct reference checks, at either or at both of the following two points of the evaluation process:

- 1. After proposals are evaluated, for the proposer or proposers with the highest-scoring proposal(s);
- 2. In the event that interviews are held, for the proposer or proposers with the highestscoring proposal(s) and interview(s).

In the event that information obtained from the reference checks reveals concerns about any proposer's past performance and their ability to successfully perform the contract to

SHA Solicitation No. 5840 Page 9 of 18 be executed based on this RFP, SHA may, at its sole discretion, determine that the Proposer is not a responsible proposer and may select the next highest-ranked Proposer whose reference checks validate the ability of the Proposer to successfully perform the contract to be executed based on this RFP. In conducting reference checks, SHA may include itself as a reference if the Proposer has performed work for SHA, even if the Proposer did not identify SHA as a reference.

By submitting its proposal in response to this RFP, the consultant accepts the procurement method used and acknowledges and accepts that the evaluation process will require subjective judgments by SHA and the evaluation panel.

#### **G. CONTRACT NEGOTIATIONS**

SHA shall negotiate with the most qualified Proposer or Proposers, as determined by evaluation of the responses and, if applicable, interviews. If SHA is unable to reach agreement with any of the highest ranked firms, it may negotiate with the next highest ranked firm or firms, proceeding in turn to each firm that SHA has determined to be qualified, in order of rank. If agreement cannot be reached with any qualified firm, SHA reserves the right to cancel the solicitation.

SHA expects to execute one or more Contracts for services for one year. At SHA's option, a Change Order may be executed extending the Contract(s) for up to four additional one-year periods, along with appropriate adjustments in the scope of work and compensation.

#### H. ADMINISTRATIVE INFORMATION

- 1) Small and/or Disadvantaged Business Enterprise Requirements: SHA strongly encourages minority-owned and women-owned businesses, socially and economically disadvantaged business enterprises, HUD Section 3 businesses, small businesses and veteran-owned businesses to submit proposals, to participate as partners, or to participate in other business activity in response to this RFP.
