**Item 2**. The following is a list of questions received and SHA's responses to those questions.

Question 1. The project manager mentioned additional plans and subject area information could be found on the Builders Exchange website, however we did not find anything listed under SHA for the Willis House. Can you please provide a link or attachment of this information?

Response: See Item 1 above.

Question 2. Item #6 – O&M manual. Is this referring to the RainWise standard brochure or do you require a custom manual?

<u>Response:</u> The contractor should provide a basic operations and maintenance manual for the proposed system detailing preventative and routine maintenance requirements, as well as basic system operation.

Question 3. Item #4 – Will the selected contractor be given a retainer at the beginning of the project to cover up-front project costs?

<u>Response:</u> No, the Seattle Housing Authority is not allowed to pay for work until after it is performed and progress invoices are approved.

Question 4. County parcel information indicates the building was built in 1983. Has the existing CSO been scoped recently to determine if the pipes are intact with no breaks in the line out to the main?

<u>Response:</u> Not to SHA's knowledge. For further information on this detail, please contact the King County Wastewater Treatment Division.

Question 5. Do the residents or staff at Willis house have an intention for captured cistern water, e.g., seasonal planting irrigation?

Response: Not currently.

<u>Question 6.</u> Will the selected contractor be asked to attend a public meeting at the Willis House to discuss the proposed green infrastructure plan with the residents?

<u>Response:</u> There is potential for some resident engagement, however SHA does not have these meetings scheduled at present.
