This Addendum containing the following revisions, additions, deletions and/or clarifications, is hereby made a part of this solicitation for the above-named project. Bidders/Proposers shall take this Addendum into consideration when preparing and submitting their response to this solicitation.

This Addendum lists questions received and SHA's responses (see Item 1 below) and adds the List of SHA Playgrounds (see Item 2 below).

Item 1. The following is a list of questions received and SHA's responses to those questions.

Question 1. Will there be any other opportunities/times offered for the pre-submission conference or will there be notes from the meeting that will be available?

<u>Response:</u> Under Addendum #1 a second Pre-Submittal Meeting is scheduled. Notes are not taken and will not be made available.

Question 2. Do you have the approximate locations or addresses for the parks and/or playground required to be inspected? Can a spreadsheet or map be provided?

Response: Yes, the addresses are provided in the attached 'List of SHA Playgrounds'.

Question 3. How many total playground sites will need to be inspected?

<u>Response:</u> There are 21 total playground sites, and potentially more in the future.

<u>Question 4.</u> What is the completion timeline for the playground inspections? Does the project need to be completed within a certain timeline? Example: If I go out and inspect a site in January that outlines safety priorities and recommendations for ADA improvements, when and how would I know to return to the site for a post-inspection?

<u>Response:</u> We hope to complete the initial playground inspections within the first year of the Contract. If a site needed a post-inspection, we would coordinate with the Contractor for a schedule that works for both parties.

Question 5. What is the length of the contract?

<u>Response:</u> The initial contract shall be established for one year, with an option to extend the contract for up to four additional one-year periods.

<u>Question 6.</u> Is this an ongoing service like an annual inspection or are you looking for a one-time inspection for each site?

<u>Response:</u> Within the first year of the Contract, we hope to complete initial inspections for all sites. Based on the maintenance and ADA-compliance recommendations, we may extend the Contract for annual and/or biannual inspections, and future renovation projects.

<u>Question 6.</u> If our business is <u>not</u> a "Subgrantee" or "Contractors" outlined in the For-Profit Subgrantee and Contractor Certifications and Assurances do we have to complete the form?

<u>Response:</u> All fields on the forms must be completed. If a field is not applicable, "N/A" must be entered.
