<u>Response:</u> Bidders have an opportunity to use their own fee sheet and estimate the total hours and cost for a similar project. Project parameters to base cost on can be a 100-unit apartment, typical 5 floors of wood frame over 2 floors of concrete (1 SOG and one PT transfer deck), permitted in the City of Seattle (COS). Inspections noted on Exhibit 1 are the typical reoccurring inspections required by the COS. This is not and exhaustive list and offers enough bidder information to evaluate Criterion 4.

To complete RFP evaluations, SHA needs to see the unit price/rate for each category noted in Exhibit 1 and the firms typical total hours estimated to complete each task for the project noted in this response.
