5460 – Common Area Lighting Replacement Phase II Seattle Housing Authority Locations

PROJECT DESCRIPTION: This is a multi-site project to replace common area lighting fixtures in 9 public housing communities with energy efficient hardwired LED fixtures. The project seeks to maximize energy efficiency and reduce energy consumption as part of the Seattle City Light Multifamily Common Area Lighting Program. Common areas include, but are not limited to: stairwells, corridors, community rooms, exterior pathways, parking areas, and entry lighting. Approximately 1659 light fixtures are targeted for replacement, lamp retrofit, or removal.

LOCATION: The project is located at various Seattle Housing Authority Sites.

ESTIMATE: The estimate for this project is between \$260,000 and \$290,000

<u>BID SUBMITTAL:</u> Sealed bids will be received for this project by the Seattle Housing Authority (SHA) at its offices at 190 Queen Anne Avenue North, Seattle, Washington 98109, only up to **1:00 PM**, on **August 10, 2021** after which time bids will be publicly opened and read. Bids received after 1:00 PM will not be accepted or read.

Bids that are properly submitted will be publicly opened and read aloud. The Public Bid Opening will be conducted via TEAMS meeting and / or telephone. No bidders will be allowed to attend (in person) the bid opening conducted at the Seattle Housing Authority Central Office.

No bidder may withdraw its bid within 60 days after the required bid submission date.
